## POLICY FOR DISABLED-FRIENDLY

### CAMPUS AND COLLEGE

#### Objective:

It is necessary to design a basic policy outlining the College's approach to making the College campus, structures, equipment's and processes so that no person is restricted from accessing it, whether as student, staff member or an ordinary visitor. While there are several laws and regulations, these do not constrain the College from going beyond, and there are times when the executives need a more fundamental guideline.

#### "Prevention is better than cure"

It is better to undertake disabled-friendly measures, so that they are able to derive maximum benefit technically feasible from the campus, structures, equipment and processes as would any normal person.

#### Mechanism:

1. There are clear laws prescribing the Rules, Codes and processes for the disabled. These must be strictly adhered to, along with regulations and instructions from authorities like Government, UGC, university etc.
2. Even when laws allow greater flexibility in framing these, the following issues must be addressed fully and transparently:
  - a. Clear and explicit identification of the schemes, policies and processes
  - b. Fairness in the following processes:
    - i. Communication of the schemes, policies and processes - through documents handed over to the persons, through College Notice Boards, website etc:
    - ii. Implementation of the same, and proposals for modification in the Rules and Codes


